### 7. General Manager and Staff Reports

#### Ben Shawcroft, General Manager

Shawcroft reported that the Big Berm is almost complete; he also presented photographs of the construction at the Big Weir. The Bill AB325 has died and will not be moving forward.

Herwick reported on current conditions in the Carson Division. See the attached report. With soil saturation levels so high, the drains in the Carson Division are unable to keep up. Maintenance crews are cleaning them to try and help promote faster drainage. Ditchriders are still running high water monitoring 24/7 and are also checking Derby Dam on a regular basis.

## Mark Solinski, Hydroelectric Facilities Manager

Solinski reported that the elevation of Lake Lahontan is increasing slowly. New Lahontan Power Plant is producing 2,600 KW, Old Lahontan is producing 950 KW and 26' Drop is producing 1,000 KW. The grant application for the 26' Drop runners has been approved.

# 9. United States Fish & Wildlife Service (USFWS) – General Updates

Trackas Carson mejaton (Astro) Regular Session Modime Minutes May 2: 2020 Property of S Bethany Chagnon, Deputy Refuge Manager, reported that there is plenty of room for water available in the Refuge; and that the Fish & Wildlife Office has moved to its new location on Freeman Lane.

## 10. <u>Bureau of Reclamation – Lahontan Basin Area Office (LBAO) Representative(s) –</u> <u>General Updates</u>

Jack Worsley, LBAO Area Manager, reported that the contractor in Fernley will be pouring a 70' test section of lining next week.

11. <u>Fallon-Paiute Shoshone Tribe (FPST) – General Updates</u>

Leanna Hale, Land & Water Director, reported that the Wetlands are receiving spread water and so far everything is running smoothly this season.

- 13. <u>Natural Resources Conservation Service (NRCS) General Updates</u> There was no representative present to report.

# 14. Nevada Department of Wildlife (NDOW) – General Updates

Jake Ward, Wildlife Technician, reported that water levels in the Carson Lake Pasture have risen to roughly equal to levels in 2017. Water has reached the Berm along Pasture Road and several other roads are closed.

### 15. Hearing on Petition for Inclusion of Lands to the District - 9:00 a.m.

Public hearing relating to decision by the Board, made pursuant to NRS 539.708 et seq., as to whether or not to include lands in the District, upon petition by Darren James Leitzke and Sharon Leitzke of Fallon, Churchill County, Nevada. The land consists of Assessor Parcel No. 007-111-30 and bears the physical location of 75 Bench Road, in Fallon, Churchill County, Nevada. The failure by any person to show cause as provided for upon notice given pursuant to NRS 539.712 shall be taken as assent on that person's part to change of the boundaries of the District so as to include the whole or part of the land mentioned in the petition.

General Manager Shawcroft presented an overview of the annexation request; no comments have been received from the public.

A <u>motion</u> was made by Director Gomes to approve the Annexation of Parcel Number 007-111-30 owned by Darren James Leitzke and Sharon Leitzke, seconded by Secretary Oakden, request for comment and the motion was unanimously approved.
